ABOUT THE WORKSHOP

Day 1: Bird conservation initiatives in India: India's diverse avian population is a testament to the country's natural richness. However, these beautiful birds face multiple threats, ranging from habitat loss to climate change. Conservation efforts are essential to safeguard their future. Many countries/ regions/ organizations/ conservationists are taking proactive steps toward conservation of wild birds and their habitat. This will be discussed during day.

Day 2: Illegal hunting, taking and trade of birds: Illegal hunting, taking and trade of wild birds are common worldwide and threaten biological diversity. Over-exploitation is one of the main drivers of bird extinction globally, and is the second most significant threat (after habitat loss) to migratory birds. Killed or trapped in huge numbers, some species are being driven to extinction

There is a wide range of reasons for the illegal killing, taking and trade on wild birds – subsistence uses, recreational activities, organized crimes, traditional practices and so on. They vary from country to country and region to region, according to what has been defined as legal or illegal – is at all. Indeed, in many countries clear regulations do exist, but enforcement needs to be improved and strengthened. Illegal activities not only affect bird populations, but also harm society in general, putting our natural resources and and our very existence in danger. Conservation, agriculture and tourism sector – all suffer from their negative impacts. On the second day, the illegal hunting, taking and trade on wild birds will be discussed in detail.
